and organizations purchasing tables or tickets. In most cases, individuals and organizations may issue invitations to the Chairman's Dinner without the involvement of the FCBA. Some agencies, departments and branches of the Federal Government, however, apply additional stipulations above the regulations issued by the Office of Government Ethics. Individuals who have signed the Administration's Ethics pledge cannot accept invitations from most registered lobbying organizations or registered lobbyists. While this event has qualified as a widely-attended-gathering in previous years, each FCC employee is required to obtain individual ethics clearance based on matters they are working on within the Commission. Employees of the Commerce Department are required to obtain individual ethics clearance through the Department's Office of General Counsel. Invitations to Members of Congress, Congressional Staff, and employees of the Department of State must be issued by the FCBA. Contact the FCBA for additional information.

In 2010, the Department of Justice and the Federal Trade Commission released revised *Horizontal Merger Guidelines*. The Federal Communications Commission's analysis generally follows, and is consistent with,

the *2010 Horizontal Merger Guidelines*. Unfortunately, no similar guidance has been released in recent years as to how the antitrust agencies and the FCC will evaluate vertical mergers. During this program four distinguished antitrust scholars and practitioners, two of whom helped develop the *2010 Horizontal Merger Guidelines*, will discuss the issues raised by vertical mergers, including both potential efficiencies and potential competitive concerns. They will also discuss how the antitrust agencies and the FCC have reviewed vertical mergers in the past and how they are likely to do so in the future. Finally, they will provide practical advice for lawyers representing clients in such mergers.

Thursday, December 11, 6:00 – 8:15 p.m. Internet Governance: Results of Plenipotentiary-14, and Prospects for IANA Transition and UNGA-15

The FCBA International Telecommunications Committee will hold a CLE on Thursday, December 11 from 6:00 p.m. – 8:15 p.m. entitled “Internet Governance: Results of Plenipotentiary-14, and Prospects for IANA Transition and UNGA-15.” This program will be held at a location to be determined in Washington, DC.

In December 2012, the International Telecommunication Union (ITU)

held a treaty conference to revise its Telecommunication Regulations (WCIT). That conference exposed a rift between those Member States who wanted greater control over Internet Governance and those – such as the U.S. and Europe – committed to the Multistakeholder model. Subsequent surveillance-related issues underscored the importance of these issues at subsequent meetings at the ITU, at other U.N. bodies, and at various “multistakeholder” groups and meetings. In spring 2014, the Department of Commerce launched a process to transfer its remaining oversight of the “IANA” function. This kick-started a process being coordinated by the Internet Corporation for Assigned Names and Numbers (ICANN), and initiated Congressional debate about the wisdom of this action. In addition, Internet Governance issues will be central to the quadrennial ITU Plenipotentiary Conference, held October 20–November 7 in Korea. Finally, the U.N. General Assembly (UNGA) will address these issues in 2015.

This CLE will examine the legal and policy outcomes of the Plenipotentiary, and how any alterations to the treaty or resolutions (particularly regarding Internet Governance) could affect U.S. interests, including business. It also will review the IANA transition process to date and expected future timing. Finally, the CLE will examine how to maximize the private sector's role in UNGA's 2015 review of Internet Governance.

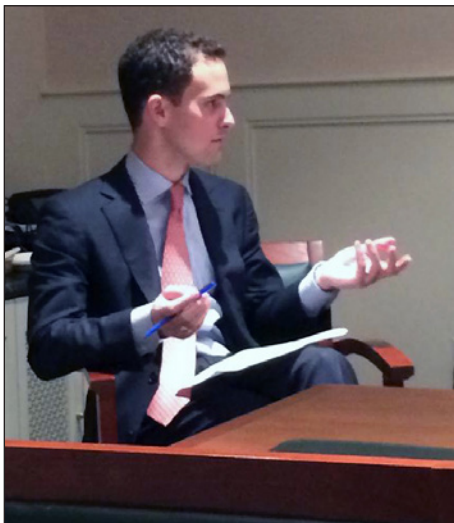

New England Chapter Hosts "Deregulation – How's It Going?" Program on October 2

The New England Chapter, in conjunction with the Boston University College of Communication, presented "Deregulation – How's It Going?" on October 2nd. An audience of New England regulatory staffs, practitioners, and students enjoyed an interesting and informative discussion of deregulation efforts, effects, and related policy issues, both nationally and in New England.

After welcoming remarks by Chapter Co-Chair Joshua Pila, Tom Fiedler, Dean of the College of Communication, opened with observations on the changing nature of communications and the corollary conclusion that deregulation is an ongoing topic that would be just as fresh if we had this event next year. Dean Fiedler was followed by Commissioner Karen Charles Peterson of the Massachusetts Department of Telecommunications and Cable. Commissioner Peterson noted that each New England state would tell a different tale of deregulation. In Massachusetts, the Department's deregulatory objective is to remove regulations that do not protect consumers, ensure a fair marketplace, or address public safety.

The first of our two panels began with a recap of twenty years of telecommunications regulation and deregulation by Chapter Co-Chair Rob Munnely. A rousing discussion among representatives of various industries and interests followed.

Sam Kline, Vice President for Corporate Strategy at Granite Telecommunications, noted that Granite adds 1000 resold POTS lines a day, and presented statistics showing significant price increases for business telephone lines after deregulation in numerous states. Regulation of ILEC-delivered services remained critically important to Granite.

Rick Cimerman, Vice President of External and State Affairs at the National Cable and Telecommunications Association (NCTA) opined that deregulation was going “pretty darn well.” He remarked that the cable industry had voluntarily submitted to regulation in such important public policy areas as CALEA and E-911 but that light touch regulation by federal and state authorities helped foster innovation and investment that benefitted consumers.

Matt Gerst, Director of State Regulatory & External Affairs at CTIA - The Wireless Association, cited the existence of 14.2

million mobile connections in New England, equivalent to 98% of the population, as well as the 30,000 jobs that the “app economy” has created in the region. He also attributed this success to a “light touch” regulatory environment but urged that additional spectrum be made available to support growth and new services.

Michael Reed, State President - Maine of FairPoint Communications, said that since acquiring Verizon’s ILEC operations in Maine, New Hampshire, and Vermont, FairPoint had undertaken a \$700 million network upgrade. Pricing flexibility is important to FairPoint and has helped it competitively in the states where

implemented. However, he noted that FairPoint cannot afford to be regulated when it only has a relatively limited share in certain markets and it competes with entities that are not subject to similar regulations.

Wayne Jortner, Senior Counsel with the State of Maine Office of Public Advocate, highlighted some of the negative effects of retail deregulation, including

price increases in ILEC voice services, decreased service quality, withdrawal of services, diminished modes of service, and price discrimination. He cited a Carnegie-Mellon study that found that price increases in big states result in price increases all over the country by raising the average rate for USF purposes.

The second panel was entitled "The Economic and Investment Perspective" and was moderated by Chapter Co-Chair Greg Kennan. The panelists were Anna-Maria Kovacs, Visiting Senior Policy Scholar, Georgetown University Center for Business and Public Policy, and Timothy J. Tardiff, principal with Advanced Analytical Consulting Group in Boston.

Anna-Maria Kovacs discussed the significant changes in the telecommunications industry in recent years and highlighted the need for a new "network compact" that would establish rules for different service platforms that would reflect the new competitive realities. She pointed out that only 30 percent of consumers rely on ILEC POTS lines for voice services, with the remaining 70 percent spread among wireless, cable VOIP and other serving options, and that consumers seemed to be "voting with their feet" and leading the way into new

non-traditional services. The regulations associated with the new compact needed to be reasonable, or else consumers would just evade the rules and migrate to less regulated services, as they had been doing so. Consumer want "more and faster" in terms of broadband speeds and capacity, and regulation has a limited role in many of these areas. Regulation retains importance in areas such as public safety, low income Lifeline service, and rural and high cost urban areas.

Tim Tardiff highlighted different data but reached somewhat similar solutions regarding the evolving telecommunications landscape. He observed that no one on the first panel suggested that telecom should be fully deregulated; the focus should be on the appropriate level of regulation to meet policy needs. He cited various data points showing strong trends at both state and federal levels favoring movement away from regulated services and towards deregulation and not attempting to re-regulate (such as the dozen years spent studying special access deregulation with no apparent retrenchment seen yet). He noted that despite some early discussions of how Europe seemed to be ahead of the U.S. in broadband deployment, the U.S.'s light touch has spurred investment and surpassed Europe; European leaders are

now complaining that its ILEC-heavy, regulatory model is not well suited to expanding broadband compared to the U.S. model. There are certainly areas where regulation is needed to spur additional broadband in the US, and FCC leaders will have to figure out the tough policy issues to make the revised USF program useful in achieving societal goals.

A reception followed the event. The Chapter wishes to thank our hosts at the College of Communication and our reception sponsors: Comcast, Granite Telecommunications, and Verrill & Dana.

Get to Know an FCBA MEMBER

Tom Power

I recently sat down with White House telecommunications policy guru Tom Power. Tom currently is Deputy Chief Technology Officer, Telecommunications in the White House Office of Science and Technology Policy (OSTP). Tom last year completed a three-year stint on the FCBA's Executive Committee and Tom has been an FCBA stalwart for some time. Those of us that have worked with Tom know how very serious he is at all times – not. So there was no lack of laughs during our late afternoon meeting as we reviewed some highlights of his years in communications law and policy, among other things.

Q: What attracted you to the field of communications?

A: I guess it goes back to my days as a college radio station DJ at the University of Virginia, or maybe my time in law school in Charlottesville, when I was a news anchor and a reporter, who knows? I got involved in communications tangentially as a commercial litigator at the law firm of Winston and Strawn starting back in 1990. It was a great firm and still is, but over time I discovered there were parts of commercial litigation that I liked and parts I didn't like as much. One part that was interesting was learning about different sorts of businesses, including by working on a large number of communications cases. Then after the Congress passed the 1992 Cable Act, I decided it might be exciting to work at the FCC, and I worked in the then Cable Bureau as Deputy Chief of the Policy and Rules Division. I later moved over to what was then the Common Carrier Bureau from 1994 to 1997, helping run the Competitive Pricing Division. As you might imagine, these were incredibly interesting times to be involved in massive statutory implementations of the Cable Act and then the Telecommunications Act of 1996.



Q: Tell our readers whether you were deliberate in your career progression and how things unfolded.

A: I can't say that I really had any deliberate game plan. Looking back I think I was just lucky that I somehow managed to impress FCC Chairman Bill Kennard to the point that he hired me as his Legal Advisor and later his Senior Legal Advisor. After that I left the agency in 2000 to go to work at Fiberlink, a company started by a friend of mine from high school and college. That move was due to a chance conversation one night when my friend was talking to me about needing a lawyer to be his General Counsel. He figured pretty much all lawyers could function in that role, and I let him indulge that fiction. But I thought, when else would I ever have the chance to learn corporate law on the job? I was the 50th employee and when I left in 2009, there were over 250 employees. Fiberlink was recently acquired by IBM. I had done some work with the Obama campaign, but I was not exactly focused on my next job, which turned out to be moving back to DC from Pennsylvania in April 2009 to become Chief of Staff at NTIA. The opportunity was presented and I thought why not? Most recently, in August of 2011, I was detailed to the OSTP, which is where I am right now.

None of these jobs came to me through any sort of premeditated design; I've just been incredibly lucky so far.

Q: What is the most challenging part of your current position and why?

A: A lot of what we do at OSTP is to attempt to coordinate policy and activities across a range of federal agencies. Each agency of course has its own leadership, mission, legal framework and set of responsibilities and often each answer to different committees on the Hill. That coordination piece can be very challenging but when it all works it's great. And I find I kind of enjoy that challenge. One example of this was the coordination shown between NTIA and the Rural Utilities Service in the US Department of Agriculture. Both entities were designated as grant agencies under the Recovery Act in 2009 for broadband deployment grants. Rather than having two entirely inconsistent sets of rules and criteria, the agencies were able to coordinate many aspects of their processes so that participants didn't have to figure out two sets of rules. Another area where cross-agency coordination is both fun and challenging would be in spectrum policy, including for example the work behind brining the AWS-3 spectrum auction forward.

Q: What are you reading now?

A: I've always enjoyed reading history and biographies, but now I'm increasingly drawn to nonfiction. I've just been reading Michael Lewis's book "Flash Boys" which is about the advantages some in Wall Street carved out for themselves in the high frequency trading game. To me it was fascinating how the traders themselves merely thought about optimizing their technology and only later, if at all, about the ethics of what it was they were doing.

Q: What surprised or impressed you most about the people you've worked with and why?

A: The person who impressed me the most in my career so far is Bill Kennard. He is the type of guy DC needs more of, extremely smart and talented, but so unassuming, so lacking in ego. I learned so much working with him, it was terrific. Taking it from the personal to the general, in the communications bar and broader field it does sometimes feel like we are living a small town and I mean that in a very positive way. We try to look out for each other and that's a good thing.

Q: Can you share a perspective on pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: The thing that comes to mind for me on this point is the book by Robert Fulghum, "All I Really Need to Know I Learned in Kindergarten." It's basically got it all there, be kind, if you make a mistake or hurt someone say you are sorry, that sort of advice. I mean, really, I see folks from time to time who are highly enamored of themselves or who exhibit poor personal behavior and that sticks with you about that person. I find that people tend to remember how you treated them long after they met with you in the Chairman's office and you and they are off doing something entirely different. So that's my advice on a pitfall you can avoid by just remembering the fundamental kindergarten rules of behavior.

Q: What's something interesting about you that people are not generally aware of you are willing to share?

A: I mentioned my college DJ gig before, but I didn't mention I was on a DJ team with none other than the great Kathy Kirby of Wiley Rein. Of course, we have a mutual secrecy pact about those days -- but do ask her about Dave Edmunds if you get a chance. Another fact is that during a federal government shutdown you are allowed to work for pay so long as what you do is entirely unrelated to your government job. So last year during the shutdown I was a bartender for a bit. I have the picture to prove it.

And here's a real gem....those who have been around for a while may recall as Reed Hundt was stepping down as FCC Chairman that there was press speculation that he was a candidate to become the next Commissioner of baseball. The day before his last FCBA Chairman's Dinner the word went out that a baseball glove was needed for the Chairman's dinner speech. My glove was a prop in his monologue. To thank me for its use, Reed kindly autographed it. I bet I'm the only person in the world with a baseball glove autographed by Reed Hundt. And certainly the only person who would want one!

Q: How long have you been an FCBA member and what is the value of FCBA membership?

A: I've been an FCBA member about 20 years. The FCBA creates a very

necessary space where we can interact personally and professionally and be better at what we do because of those interactions. I really look forward to our signature events like the Annual Seminar, the Chairman's Dinner, the Charity Auction and substantive programming too. In MEMORIAM

Thomas S. Schattenfield (1926-2014)

Retired communications attorney Thomas Schattenfield died on August 19, 2014 at 87. A native of Cleveland, Ohio Tom received his undergraduate degree from the University of Michigan in 1947. He served in the United States Navy. After receiving his law degree from Western Reserve University Law School in 1955, he was hired by the U.S. Department of Justice under the Attorney General's Honors Program. He worked at DOJ in litigation for six years, including two years as an Assistant United States Attorney for the Southern District of Ohio.

Tom joined Arent Fox Kintner Plotkin & Kahn in 1961 and became the firm's "go-to" litigator for broadcast clients until he retired in 2000.

He was a central player in the WHDH, Inc. case involving the application of comparative hearing guidelines to the renewal application hearing for a TV station in Boston.

While at Arent Fox, Tom served as General Counsel of the National Radio Broadcasters Association. On behalf of the NRBA, Tom filed an *amicus curiae* brief in support of

Simon Geller's appeal from the FCC's denial of renewal for station WVCA-FM, Gloucester, Massachusetts, and award of the license to a competing applicant. Mr. Geller had operated the one-man classical music station out of his apartment seven days a week for 24 years, subsisting on donations from his small radius audience.

The competing applicant promised more diverse programming. In reversing the FCC's decision, the D.C. Circuit adopted the reasoning in Tom's brief, providing an important step in the development of "renewal expectancy" jurisprudence.

He represented intervenor Greater Philadelphia Council of Churches in successfully urging the D.C. Circuit to uphold the FCC's first denial of license renewal (for stations WXUR/WXUR-FM, Media, Pennsylvania) for failure to meet the affirmative Fairness Doctrine/personal attack rule obligations which had been set forth in the U.S. Supreme Court's *Red Lion Broadcasting* decision three years previously.

Tom represented the United Broadcasting Companies in the defense (ultimately successful) of their multiple major-market radio station licenses, which had been challenged by competing applicants.

His other clients included Pacifica Foundation which, with its defense of station WBAI's broadcast of George Carlin's "seven dirty words," led to the U.S. Supreme Court decision setting the limits of government regulation of broadcast speech.

Tom was deeply committed to public service. He was instrumental in establishing the pro bono program at Arent Fox and served an active role (including Chairman 1989-1993 and Co-Chairman 1993-1996) until his retirement. Tom served as President of the Board of the Legal Aid Society of the District of Columbia (1996-1998) where, according to his colleagues, his vision and "thinking outside the box" has had a lasting impact on making it the robust organization it is today.

Tom served as Treasurer of the FCBA (1987-1988).

According to Tom's former colleagues at Arent Fox, Tom was a natural litigator. He was indefatigable, and a perfectionist, in representing clients. Working with him was challenging, exciting, interesting – and fun.

After retirement, Tom enjoyed spending time with his wife Judith and their seven children and ten grandchildren. He also enjoyed gardening, reading, and cheering on the Boston Red Sox and Cleveland Indians.
